BOARD GOAL SETTING SESSION

RECOMMENDATION:

Review and provide input on the proposed 2025 EPPBID Board Goals.

BACKGROUND/ANALYSIS:

The purpose of this Goal Setting Session is to review the progress made on the FY 2024/25 El Paseo Parking & Business Improvement District (EPPBID) goals, assess ongoing projects, and receive direction on priorities for FY 2025/26. This session will provide an opportunity to align EPPBID resources and strategic efforts with the evolving needs of the District.
