NOTICE IS HEREBY GIVEN THAT A PUBLIC HEARING WILL BE HELD BEFORE THE CITY COUNCIL OF THE CITY OF PALM DESERT, CALIFORNIA, TO CONSIDER ADOPTING A NOTICE OF EXEMPTION PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) AND APPROVE A CHANGE OF ZONE FOR THE PROPERTY LOCATED AT 73600 ALESSANDRO DRIVE TO DOWNTOWN EDGE BY REMOVING THE DOWNTOWN EDGE TRANSITION OVERLAY

The City of Palm Desert (City), in its capacity as the Lead Agency for this project and pursuant to the California Environmental Quality Act (CEQA), has determined the project to be exempt from further environmental review pursuant to CEQA Guidelines Section §15061(b)(3).

PROJECT LOCATION: 73600 Alessandro Drive in the City of Palm Desert, located in Riverside County. Assessor's Parcel Numbers 627-153-018 and 627-153-019

PROJECT DESCRIPTION: The consideration is a request to change the existing designation of the property to Downtown Edge (DE) by removing the Downtown Edge Transition Overlay (DE-O).

<u>PLANNING COMMISSION RECOMMENDATION</u>: The Planning Commission for the City of Palm Desert did hold a duly noticed public hearing to consider the Change of Zone on February 20, 2024 and adopted Resolution 2855 recommending approval of the project to the City Council.

<u>PUBLIC HEARING</u>: NOTICE IS HEREBY GIVEN that the City Council of the City of Palm Desert, California, will hold a Public Hearing on Thursday, <u>March 14, 2024</u>.
