#### **RECOMMENDATION:**

#### **BACKGROUND/ANALYSIS:**

The Civic Engagement Committee convenes quarterly to discuss and promote civic education and engagement to help residents better understand local government, foster a positive sense of community, and prepare the next generation of local government leaders.

At the January 18 meeting, staff presented a recommended work plan, identifying three projects for the committee's consideration. Members were invited to propose additional projects either during the item's discussion period or by email prior to the April 18 meeting.

No further proposals were submitted by committee members during discussion or subsequently by email. At the April 18 meeting, the committee unanimously approved the 2024/2025 work plan.
