To the City of Palm Desert:

I am a Palm Desert resident and just learned that you are trying to enforce new guidelines to eliminate dining decks on El Paseo and Highway 111. I felt the need to voice my objection to your proposed new guidelines and urge you to please allow restaurants to keep their outdoor dining decks.

Many businesses invested a lot of time and money building outdoor dining spaces during a time when it was a struggle just to stay afloat. Now with nationally rising food and other costs it's hard enough to keep any business going. These dedicated local businesses (and yes, we're mostly talking about locally-owned, non-chain businesses) contribute hugely to our community and give patrons like me a much-needed sense of belonging that becomes more important every day.

The last thing you should do is make it even more difficult for our local businesses to stay afloat, or to punish local residents by removing crucial communal gathering spaces where we can support our local businesses. I see no benefit to removing outdoor dining decks. Abundant parking is already available around both El Paseo and 111 so there is no pressing need to free up more pavement. Your proposal would only have the opposite effect: making it harder (or sometimes impossible) for customers to patronize smaller establishments during busy times if space were to be limited to indoor seating. A few words in support of parklets in Palm Desert.



Hello, my name is Owen Whitehall. My wife and I own a property in Palm Desert and spend the winter and spring here. We love this city and all that it has to offer. It's truly a unique place and has earned the accolades it receives.

We like many others enjoy El Paseo for its shops and restaurants. We eat out at least 3-4 times a week and typically it will be at one of the locations on El Paseo. The one good thing that came from the COVID days is the outdoor dining patios/decks that many businesses installed. Given the weather here in the desert, it truly improved many of these businesses and added capacity for them as well.

We have gotten to know many of the owners/managers of these restaurants here in PD. We share their concerns on the timing and costs associated with your proposed changes. In addition, we understand there is a proposal to pave El Paseo, which seems unnecessary given the condition of the roadway.

It would only seem prudent to delay both of these programs until a better plan is in place, more information obtained and a fair amount of notice to allow businesses to budget and plan for such programs.
