And, the City of Palm Desert needs to do better in stepping up and being more vocal about protecting their elected officials, against all threats.

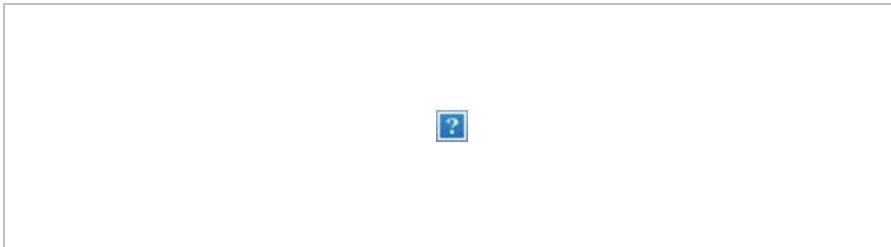
