## **Details:**

The Palm Desert Sheriff's Station Special Enforcement Team (SET) and the Riverside County Anti-Human Trafficking Task Force (RCAHT) received a tip about a possible illicit massage parlor operating in the 45000 block of San Pablo Avenue in the City of Palm Desert. An investigation revealed that prostitution activities were occurring at the location.

On November 26, 2024, Palm Desert SET and RCAHT served a search warrant at the location. During the operation, Haiwei Donkersgoed, 58, was arrested for maintaining an illicit brothel (315 PC) and booked into the county jail in Indio. Two additional females were located at the business who were identified as possible victims of human trafficking. The females were provided with in-person advocacy services and resources, then released from the Sheriff's Station in Palm Desert. Multiple suspected sex buyers were contacted at the location and later released pending further investigation.
