A. Term is extended to add the following paragraph to the end of the existing section, as amended.


"The term of this Agreement is extended, and shall include the time period from July 1, 2019 through June 30, 2020."

B. All other terms and conditions of the Agreement shall remain unchanged, and shall remain in full force and effect.


