SUBJECT: REJECT BIDS SUBMITTED FOR THE DESERT POINTE APARTMENT NUMBER 13 INTERIOR RENOVATION

#### **RECOMMENDATION:**

- 1. Reject all bids submitted in response to a Formal Bid Request for the interior renovation of unit #13 at Desert Pointe Apartments.
- 2. Authorize Staff to solicit bids for these services and to include additional interior renovations needed throughout the Palm Desert Housing Authority properties.

## BACKGROUND/ANALYSIS:

On March 14, 2025, the Palm Desert Housing Authority ("Authority") issued a Notice Inviting Formal Bids on the City's procurement portal OpenGov for Desert Pointe Apartments - Unit 13 Interior Renovation. The Notice was also published in the Desert Sun newspaper. A mandatory pre-bid meeting was held on March 25, 2025, and eight contractors were in attendance. Bids were due April 14, 2025, and two bids were received as follows:

After reviewing the submitted bids, Staff identified the following concerns:

- Both contractors were present at the pre-bid meeting to observe the needed repairs at the unit. However, there is a significant difference in their bid amounts, and there does not appear to be an error.
- At the pre-bid meeting interest in multiple renovations at the same time was expressed by attendees.

Staff has since been made aware of two additional interior renovations needed at another property.

Staff recommends rejecting the bids and opening a new Notice Inviting Formal Bids to include the additional units requiring interior renovation in hopes of receiving additional interest greater economy of scale, with bids that are better aligned.

### Legal Review:

This report has been reviewed by the City Attorney's Office.

#### **Appointed Body Recommendation:**

The Housing Commission reviewed this item at its regular meeting of May 14, 2025, and approved it to go to the Housing Authority Board with a 5-0 vote in support of staff's recommendation.

### FINANCIAL IMPACT:

The fiscal impact of this action is related to the cost of publication. Funds for the renovations are included in the approved FY 2024-25 Housing Authority Budget. Therefore, there is no fiscal impact to the General Fund.
