

RESOLUTION NO. 2025-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM DESERT, CALIFORNIA, ADOPTING THE REPORT PROPOSING TO HAVE SOLID WASTE SERVICE CHARGES COLLECTED ON THE PROPERTY TAX ROLL FOR FISCAL YEAR 2025-26 AND DIRECTING THE CITY CLERK TO FILE SAID REPORT WITH THE RIVERSIDE COUNTY AUDITOR CONTROLLER TO PLACE SAID CHARGES ON THE TAX ROLL

THE CITY COUNCIL OF THE CITY OF PALM DESERT HEREBY FINDS, DETERMINES, RESOLVES AND ORDERS AS FOLLOWS:

WHEREAS, Palm Desert Municipal Code Section 8.16.110 authorizes the collection of solid waste service fees for single-family residential properties through the County of Riverside's tax rolls; and

WHEREAS, a copy of the written report containing the parcel listing of all residences included in tax roll billing and the charges proposed to be assessed was made available for public review and may be obtained by contacting the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM DESERT, CALIFORNIA AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. City staff prepared and filed a written report of the charges for solid waste services for single-family residential properties to be placed on the property tax roll (the "Report").
3. Following notice duly given in accordance with law, the City Council has held a full and fair public hearing regarding the Report attached hereto as "Exhibit A" and the levy and collection of the proposed assessment for Fiscal Year 2025-2026 and heard and considered all objections and protests thereto. At the conclusion of said public hearing a majority protest was not received by a majority of the property owners subject to the tax roll billing.
4. Based upon its review of the Report, a copy of which has been presented to the City Council and which has been filed with the City Clerk and the Economic Development Department, the City Council hereby finds and determines that (i) each parcel specified in the Report benefits from receiving solid waste services (ii) the net amount to be assessed upon each parcel of real property for Fiscal Year 2025-2026 in accordance with the Report is apportioned by a formula and method that fairly distributes the net amount among all assessable parcels in proportion to the estimated benefits received by each parcel, and (iii) no assessment is imposed on any parcel that exceeds the reasonable cost of the benefits conferred on that parcel.
5. The adoption of this resolution constitutes the levy of an assessment against all single-family residential parcels of property in the City of Palm Desert identified in "Exhibit A" for the fiscal year commencing July 1, 2025 and ending June 30, 2026.
6. The City Clerk is hereby authorized and directed to file with the Riverside County Auditor Controller the assessment or a certified copy of the Report together with a certified copy of this Resolution. A certified copy of the assessment shall be filed in the office of the City Clerk and open for public inspection.
7. The City Council hereby requests Riverside County place the collection of charges for solid waste services for single-family residential parcels on the County's tax rolls as described in Section 6, and to collect the charges in the same manner, subject to the same penalties and priority of lien as, other charges and taxes fixed and collected by, or on behalf of the City.
8. This Resolution shall become effective immediately upon its adoption.
