A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM DESERT, CALIFORNIA, APPROVING THE APPLICATION FOR CANNABIS TAX FUND GRANT PROGRAM (CTFGP) GRANT FUNDS UNDER AWARD NUMBER 23348

WHEREAS, the California Highway Patrol has been delegated the responsibility by the Legislature of the State of California for administering the Cannabis Tax Fund Grant Program, establishing necessary procedures governing the grant application process; and

WHEREAS, such procedures require applicants to certify by resolution the approval of the application to the State of California; and

WHEREAS, the City of Palm Desert applied for the Cannabis Tax Fund Grant Program funds to support education, prevention, and enforcement activities addressing cannabis-impaired driving; and

WHEREAS, the City of Palm Desert has been awarded \$120,800.00 under award number 23348 to carry out these program objectives; and

WHEREAS, the City of Palm Desert will enter into an agreement with the California Highway Patrol to implement the grant-funded program activities described in the grant scope;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM DESERT AS FOLLOWS:

1. The City Council hereby approves the filing of an application for the Cannabis Tax Fund Grant Program and the acceptance of the awarded amount of \$120,800.00 under award number 23348.
2. The City certifies that it has, or will have available prior to the commencement of any work under this grant, sufficient funds to complete the project if required.
3. The City certifies that it has reviewed, understands, and agrees to the General Provisions contained in the program regulations.
4. The City certifies that it will comply with all applicable federal, state, and local laws, ordinances, rules, regulations, and guidelines as a condition of grant acceptance.
5. The City Council hereby delegates authority to the City Manager, or their designee, to conduct all negotiations, and to sign and submit all documents, including but not

limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the grant scope.
