**Acceptance and Agreement**

By accepting our work and services described herein, you are agreeing to these Terms and Conditions whether you have signed a copy of this document or not. If you object to any terms or provisions described herein, you must call us immediately.

**Loss or Damage Coverage**

Mother Lode Van & Storage will provide basic carriers liability for loss or damage of \$0.60 per pound per article at no additional charge. Claims for loss or damage must be noted on the Bill of Lading at the time of completion of the move and must be filed in writing within 30 days of the date of the move's completion. Any claim for building or property damage must be submitted to Mother Lode Van and Storage Supervisors in writing during or at the conclusion of the move while Mother Lode Van and Storage staff is still onsite. Mother Lode Van and Storage assumes no liability for articles packed or unpacked by anyone other than Mother Lode Van and Storage, its agents, or its subcontractors, nor does Mother Lode Van and Storage assume liability for any concealed damage, unless accompanied by external damage. Pressed-wood furniture is excluded of damage liability due to inherent weakness of its manufacture. The internal derangement of electronics is excluded from coverage.

**Change Orders**

Any changes, substitutions, additions to, or deletions from the survey tally sheet or move specifications may affect the Bid cost and shall be by

written order only by an authorized employee prior to the start of such work by Mother Lode Van & Storage. Delays not caused by Mother Lode Van & Storage may also affect the Bid cost. All payments for approved extras are due and payable.

### Security

Mother Lode Van & Storage will be responsible for the security of all goods only while in its possession during the actual moving process. The customer will assume responsibility for the security of goods upon delivery. The customer will assume responsibility for any rental materials provided until such time as all is returned to Mother Lode Van and Storage.

### Invoice Payment

Invoice arrangements only upon prior credit approval by Mother Lode Van and Storage management, all invoices shall be paid at the completion of services rendered. Finance charges of 5% will apply after 30 days Net on unpaid invoices. If invoice arrangements have not been approved, then the bid cost is payable prior to the move by credit card (3% service fee applies) or at the move conclusion by company check.

### Other Job Site Services

You agree that hoisting charges, field cutting and/or modifications to product and other services not specifically agreed to by us shall be in addition to the fee quoted by us and shall be billed for by us at our then customary rates for such services and equipment and due upon receipt.

### Delay

We are not responsible for delays beyond our reasonable control such as, but not limited to, late deliveries, out of service hoists or elevators, construction delays, missing or nonconforming materials, acts of God, severe inclement weather, work stoppages, strikes, supply shortages, power outages or other similar events. Any delays caused by your failure to comply with the terms of the contract (including these Terms and Conditions) shall be considered a default and may incur additional costs and charges.

### Condition of Product, Plans, Other

Unless other prior arrangements are made with our written consent, (i) all product to be installed by us shall be delivered to the job site (at no cost to us) on or before the commencement of our work complete and in good working order free from all defects and ready for installation by us (Note: We do not "accept" delivery of or inventory product. It will be necessary for you to have a representative at the job site to take delivery and receipt of product and to ensure each delivery is complete), (ii) all material and hardware necessary for complete installation shall be provided to us (at no cost to us) at the job site no later than the commencement of work by us, (iii) all product shall be of proper fit and size ready for installation by us at the job site and (iv) you must provide us with accurate drawings, plans, specifications, renderings, schematics, blueprints, and/or similar such documents as we may request ("Plans") to enable us to perform our services. You acknowledge that we may have relied upon Plans in agreeing to our fee and that to the extent the Plans may be inaccurate, we reserve the right to adjust our fee accordingly. Our services shall be strictly limited to what is agreed to in writing in the contract.

### Condition of Job Site

Prior to the commencement of work by us and during the term of our services, it shall be your responsibility, at your sole cost and expense, that (i) the job site shall be in good, clean, clear condition, complete (except for our work contracted for herein), ready for us to perform in accordance with this contract and free from interference, (ii) customary utilities are reasonably available to us including electricity, water, heat, and air conditioning, (iii) we have exclusive access to and use of a dedicated working elevator, loading/offloading and staging areas at the job site, free from interference, (iv) we have unrestricted access to the job site including security clearances passes and (v) you provide us with a 24-hour emergency contact telephone number(s).
